# Design and development of appendable elevator monitoring system to nudge people behavior change

**Abstract.** In this study, we propose a behavior change support system that encourages people to use stairs instead of elevators. Using the stairs is not only good for one's health, but nowadays it also plays a role in dense avoidance from the perspective of COVID-19.

Although many people are waiting for the elevator, we thought that if we knew how many people were on the elevator, more people could change their behavior. However, there are few buildings where the number of people in the elevator is displayed on each floor. So, we have developed a headcount measurement system in the cargo and a visualization system, those can be easily appended to the current elevator.

As a method to measure the number of people in an elevator, we propose a method to detect BLE (Bluetooth Low Energy) signals transmitted from the terminals of elevator users who have installed COCOA, an application for confirming contact with the COVID-19 in Japan, and to measure in real time the number of detected BLE signals with a received signal strength (RSSI) exceeding a certain value. We propose a method to measure the number of BLE signals detected in real time.

In this paper, we have designed and developed the system, verified the accuracy of the detection of the continuous operation time and the number of passengers, and estimated the behavior pattern and waiting time of elevator users using the system. The evaluation of the transformation of the decision making of the elevator users brought about by this system is out of the scope of this paper and will be discussed in the future.

#### 1 Introduction

Due to the impact of the COVID-19, it is becoming more important to avoid the crowded places. Trains, buses, restaurants, and elevators tend to be crowded with people. Efforts are being actively made to visualize the congestion in these places and to prevent people from being led to the congested places. In this paper, we focus on the visualization of the congestion level of elevators. The fact that




Fig. 1. System Overview

elevators are places where people tend to be crowded is mentioned in a poster by the Ministry of Health, Labor and Welfare of Japan to prevent the spread of the COVID-19[5]. The elevator is very narrow and easily crowded. Also, it is difficult for elevator users to avoid congestion. Even if the elevator is not crowded at the time when the user gets on, if many people get on at the intermediate floor, the user who was originally on the elevator will not get off unless the floor is the destination floor. In the opposite pattern, if a user presses the elevator button and waits for the elevator, but the elevator is crowded, the user may give up and wait for the next elevator or be forced to get on. This is considered to be an incident that occurs because the user cannot grasp the status of each floor and the number of people in the elevator at the timing when the elevator button is pressed. If there are users on each floor as described above, the elevator will stop at each floor, which will lead to deterioration of the transportation efficiency of the elevator and increase of the waiting time.

To solve these problems, a method of informing users of the congestion status of elevators through a smartphone application has been proposed by building company, kajima[2]. The method using a smartphone application requires the user to install an application, which raises the hurdle to grasp the congestion information. In addition, kajima[2] proposes a method for detecting passengers by using a camera as a method to grasp the congestion status in an elevator. Although the camera-based detection is highly accurate, there are some problems in terms of installation cost, such as privacy issues and the need to install a ceiling. In another approach, a gate is installed in front of the elevator and an

ID card is scanned to allow the system to know the number of elevator users and their destinations, and to select the optimal elevator and timing for boarding[3]. Since the number of elevator users is controlled by the gate, it is easy to control the number of elevator users and to eliminate the congestion in the elevators.

In this study, we propose a appendable system in which a tablet terminal is installed in front of the elevator to present the number of people in the elevator, the congestion status of each floor (Figure 1). We believe that this system will solve the problem of not being able to grasp the status of other floors and the number of people in the elevator at the time when the elevator button is pressed, which is a problem unique to elevators. Compared with the method of having users install an application, this system allows users to easily obtain information on congestion, and thus encourages them to make decisions such as using the stairs or waiting for the next elevator before pressing the elevator button.

As a part of the basic experiment, we also evaluated the continuous operation time and detection accuracy of the system, and estimated the behavior pattern and waiting time of the elevator users based on the RSSI time series data of BLE signals acquired from the system.

This paper is organized as follows. In Chapter 2, related research is described, and in Chapter 3, the outline and requirements of the elevator usage visualization system are described. In Chapter 4, the estimation of the user's behavior pattern and waiting time using the system is explained. Finally, in Chapter 5, we conclude this paper and discuss future issues.

#### 2 Related Research

In designing a congestion visualization system, the process of determining the method for measuring and estimating the congestion level and the method for communicating and visualizing the congestion information to users is important. In this chapter, we will first discuss the research on congestion measurement and general services and researches on congestion visualization, and then we will discuss the status of this research, mentioning the efforts and current status of sensing using IoT(Internet of Things) in elevators. The comparison between the related work and our proposed system is summarized in Table 1.

#### 2.1 Research on congestion measurement

A method to detect crowds by image processing using a camera has been proposed[1]. When using a camera, privacy must be taken into account. In addition, since power supply is often unavailable in elevators, it is difficult to operate the camera method on battery power all day long due to power consumption issues. As a low power consumption method for measuring congestion, we have developed a method using WiFi CSI (Channel State Information) [9] and a method for estimating congestion based on the RSSI distribution of BLE signals [11][15]. However, all of them measure the degree of congestion in the target environment from the attenuation of radio waves by installing transmitters and

receivers across the measurement environment, which requires a large indoor or outdoor space or installing devices in opposite directions.

In this study, we apply a method that utilizes signals transmitted by COCOA, the Contact-Confirming Application in Japan, which is based on "exposure notification system" codeveloped by Google and Apple. Exposure Notification is a decentralized reporting based protocol built on a combination of Bluetooth Low Energy technology and privacy-preserving cryptography. In recent smartphone operating systems, background operation is severely restricted, so it is no longer possible to create applications that continuously transmit BLE signals. Even if it were possible, it would be difficult to have a large number of people install it. COCOA, on the other hand, has already been installed by a certain number of people, and continuous background operation is specially permitted for iOS and Android.

Examples of the use of COCOA to measure congestion include the campus congestion visualization system itocon, which has been in operation in our laboratory since June 2020, [13], and an example of its use for sensing congestion in a bus [6]. In this method, only one device needs to be installed in the environment, and no application needs to be installed on the user side. The disadvantage is that not all users have COCOA installed.

# 2.2 Services and research on congestion visualization

Congestion visualization can be summarized in terms of macro and micro. From the macroscopic perspective, Google Maps and Yahoo! Map applications have started around 2015. These services were discontinued in January 2020, but have been revived again due to the Corona disaster. These services are measured based on the information of the users of Google and Yahoo! In order to

visualize the degree of restraint in going out during the Corona disaster, congestion visualization services provided by cell phone companies, such as Docomo's Mobile Spatial Statistics and Softbank's Agoop, are also gaining recognition. These services visualize the rough congestion level on a 500m mesh scale.

From a microscopic point of view, the Corona disaster has made it possible to display train congestion levels in transfer guides <sup>1</sup>. As for the level of congestion per store, a company called VACAN<sup>2</sup> has emerged.

However, since only the users in the building need the information about the elevators, it seems that no one other than the elevator companies measure or visualize the congestion level.

#### 2.3 Approaches of IoT-Based Sensing in Elevators

Some of the latest elevators are already equipped with signage that measures the number of people using cameras and weight scales, and displays the number of people in the elevator and the images from the cameras to people waiting for the elevator. However, most ordinary elevators are not equipped with such signage. Also, elevators cannot be replaced easily, so it is difficult to install them except in the latest buildings or commercial facilities. Furthermore, even in the latest buildings, such high-end elevators are not always installed due to cost and demand issues. In fact, Ito Campus of Kyushu University started construction in 2005, but at present (November 2021), we cannot find any high-end elevator with signage installed in the campus. In the case of apartments, cameras are installed in the elevators for the purpose of monitoring suspicious persons, and there are displays in the elevator halls that show the images from the cameras. While we may spend a lot of money for security, we do not often spend a lot of money to install signage to relieve congestion.

#### 2.4 The position of this research

This research aims to realize a status sensing and visualization system that can be retrofitted and easily installed in existing popular elevator systems. Although not included in this paper, we aim to support decision making, such as choosing to use the stairs instead of waiting for the train to board, and is not intended to be applied to high-rise buildings, but to buildings with a height that can be reached by stairs.

#### 3 A System for Visualizing Elevator Usage

In this chapter, we explain the system diagram Figure 1 for visualizing the number of people in the elevator and the number of people on each floor.




Fig. 2. System configuration

#### 3.1 System Requirement

To realize this system, the following requirements are necessary.

- Requirement 1: Obtain the number of people in the elevator and the status of the elevator hall on each floor.
- Requirement 2: Visualization of the information obtained in Requirement 1 for elevator users

# 3.2 System Implementation

The configuration of this system is shown in Figure 2. The reason why we are using a smartphone as the sensor to be installed in the elevator is because we thought that an inexpensive smartphone would be suitable as a platform with




Fig. 3. Application screen

built-in WiFi/BLE/LTE and a battery. The application developed in this study has a scan mode and a signage mode in one application, and can be used by simply switching between these two modes. Maintenance costs have been reduced by unifying the apps for smartphone used as sensors in elevator and tablet for displaying information. The scan mode is for smartphones installed inside the elevator (Figure 4), and only the BLE scanning function can be used. Since the basic power supply is not available in the elevator, we reduced the functions to the minimum to enable the system to operate continuously for about a day without power supply. In the signage mode, the system is designed for a tablet installed in the elevator hall (Figure 5), and in addition to the BLE scanning function, it has a feedback function with three levels of buttons and a function to display the number of people in the elevator and the degree of congestion on each floor. In addition to the BLE scan function, this mode provides a feedback function with three levels of buttons, and a function to display the number of people in the elevator and the congestion level on each floor (Figure 3). This mode basically assumes that the power can be supplied and that the lights are always on. For the implementation of the application, a framework called Flutter is used.

This section describes the technical description. First of all, in order to realize Requirement 1, we detect BLE signals of -70 dBm or higher and count the number of people. However, if all BLE signals are used to count the number of people, the problem of duplicate counting of people who own multiple devices, such as Bluetooth earphones and smartphones, will occur. Therefore, we filter out

only the BLE signals of COCOA to count only smartphone devices. Therefore, only the BLE signal of COCOA is filtered so that only smartphone devices are counted. The BLE standard for COCOA has been determined worldwide, and it is possible to filter only the signals of COCOA based on the values of [4] and ServiceUUID. However, there is a problem that the COCOA signal transmitted from the Android terminal is weak and cannot be detected if the distance is too far, but this method is used in this system because the distance between the sensor and the Android terminal is close since the elevator is a narrow and closed space. For the database, we use Cloud Firestore, and all the BLE signal data is stored in Cloud Firestore.

Next, in order to realize Requirement 2, the number of people in the elevator and the congestion level of each floor are obtained from Cloud Firestore and displayed on the tablet screen (Figure 3). In addition, in order to ask users to input the current status of the floor, the system displays the following information: crowded (more than 6 people), slightly crowded (3 people  $\sim$  5 people), and empty (1 person  $\sim$  2 people). Unlike the inside of an elevator, the elevator hall is not a shielded space, and unintended signals may be counted, so we have adopted the method of asking the users to press the buttons themselves.

# 4 Behavior patterns of people using elevators and estimation of waiting time

In this chapter, we describe a method to estimate the behavior pattern and waiting time of elevator users based on the time-series RSSI data of BLE signals obtained from the system described in the previous chapter.

#### 4.1 Behavioral patterns of people who use the target elevators

The following four types of behavioral patterns of elevator users are targeted in this study.

- Board the elevator.
- Exit the elevator.
- Use stairs instead of elevators.
- Passing in front of the elevator.

#### 4.2 Algorithm for estimating behavior patterns and waiting times

This section describes an algorithm for estimating the activity pattern described in 4.1 from time-series RSSI data. Let  $A_{hall}$ ,  $A_{right}$ , and  $A_{left}$  be the time-series RSSI data acquired from the tablet installed in front of the elevator hall, the smartphone installed in the elevator on the right, and the smartphone installed in the elevator on the left, respectively. In  $A_{hall}$ ,  $T_{start}$  is the time when the RSSI value reaches -70 dBm or higher. Let  $T_{end}$  be the time when the RSSI value drops more than 10 dBm from the maximum value. Let the time 10 seconds before  $T_{start}$  be  $T'_{start}$  and the time 10 seconds after  $T_{end}$  be  $T'_{end}$ , and let the data




Fig. 6. Time series RSSI data

of  $A_{right}$  and  $A_{left}$  from  $T'_{start}$  to  $T'_{end}$  be  $A'_{right}$  and  $A'_{left}$ . If the maximum RSSI values of  $A'_{right}$  and  $A'_{left}$  are both below -70 dBm, it is judged that "Use stairs instead of elevators" or "Passing in front of the elevator". If the maximum value of RSSI of  $A'_{right}$  is higher than that of  $A'_{left}$ , it is judged as "boarded the elevator on the right side" or "got off from the elevator on the right side", and if it is lower than that, it is judged as "boarded the elevator on the left side" or "got off from the elevator on the left side". If the time at which the RSSI value of  $A'_{right}$  reaches the maximum is later than the time at which the RSSI value of  $A_{hall}$  reaches the maximum, it is judged to be "boarding the right elevator", and if it is earlier, it is judged to be "getting off from the right elevator". The same procedure is applied to "getting on the left elevator" or "getting off from the left elevator". In the case of "getting on the elevator", the difference between  $T_{start}$  and  $T_{end}$  is regarded as the waiting time.

#### 4.3 Experimental Methods

The experiment is conducted in the elevator on the 9th floor of the West 2 Building of Kyushu University, Ito Campus (Figure 5). In this experiment, two kinds of behavioral patterns, "getting on the elevator on the right side" and "getting off the elevator on the right side", were reproduced and tested with an iPhone with COCOA installed. The experimental method is described below.

First, the participants pushed the "get off" button in front of the elevator hall on the 9th floor and waited in front of the elevator on the right side until the elevator arrived. Get on the elevator, move to the first floor, and get off the elevator. After waiting for a minute or two, press the ascending button in front of the elevator hall on the first floor and follow the same procedure to the ninth floor. Repeat this procedure for three sets. Record the time you press the




Fig. 7. Time series RSSI data and waiting time at 9F and Actual waiting time

elevator button, the time you get on the elevator, and the time you get off the elevator (Table2).

#### 4.4 Experimental results




Fig. 8. Time series RSSI data and waiting time at 9F and Estimated latency by algorithm

The time series RSSI data from 15:10:00 to 15:30:00 obtained from the tablet terminals in front of the elevator hall on the 9th floor and the smartphone terminals installed in the elevators on the right and left sides are shown in Figure 6. Based on the algorithm, the detection rate of boarding and alighting was 100%. The estimated waiting time on the 9th floor when a passenger gets on the train is shown in Figure 7, Figure 8 and Table3. Compared to Table2, the estimated wait times are roughly consistent, although there may be a time lag of 5 to 10 seconds between the estimated start time  $(T_{start})$  and estimated end time  $(T_{end})$ . Currently, the timing of the BLE scan is assumed to be about once every 10 seconds, but if the interval of the scan is shortened, the accuracy is expected to be improved.

#### 5 Conclusion

In this paper, we developed a system that measures the number of people in an elevator by measuring the COCOA signal, and visualizes in real time the congestion in the elevator and on each floor. We hypothesize that visualization of congestion to elevator users will encourage them to make a decision not to use the elevator. In the future, we plan to examine the long-term effect of this system on the increase or decrease of elevator utilization rate during congestion with and without this system. Furthermore we plan to integrate feedback mechanisms into our system to encourage behavioral changes, such as using the stairs instead of the elevator based on the IoT data-driven nudging concept [10].
